Benefits stop when your child reaches age 18 unless your child is a student or disabled If your child is a student Three months before your child's 18th birthday, we'll send a notice to you letting you know that benefits will end when your child turns 18 Benefits don't end if your child is a full-time

When can I stop paying child support?
